Understanding Your Bylaws - Part 2

In order for your bylaws to be more than a section of your secretary's binder and something to revise every three years, your board needs to understand and use your bylaws to guide your work. To help turn bylaws from a legal document to a working one, I will talk about a few articles in each newsletter for the remainder of the year.

Article V talks about requirements to be a local unit. It includes good standing requirements, directs units to keep financial records and contains the procedures for dissolving. Units cannot make changes to this article.

Article VI is about membership and dues. It states that membership is open to everyone and that all members are entitled to benefits, sets membership dues for state and national PTAs and provides for what happens if units do not submit dues. Units may add provisions about their membership. It is important to note that if units add a specific dues amount, it then needs to amend the bylaws if they want to change their dues amount. However, putting in a provision for how dues amount is decided is a good idea.

Article VII covers meeting of the association. PTAs must give the day of the month meetings are held and how many meetings will be there will be throughout the year. If meetings are not monthly, the months meetings are held must be given. The article also sets the number of days' notice is needed before changing a meeting date or holding a special meeting and sets the annual meeting and the quorum. The quorum is the number of people needed in order to vote.

Article VIII sets the rules for electing officers. The unit must list what officers they will have. It sets when the election is held and when officers take office, as well as the length of the term. There is a section that provides for the election of a nominating committee and gives the duties for that committee. Lastly, the article tells how vacancies in officers are filled. The PTA must indicate whether the vice president will fill the position in case of a vacancy in the presidency or if an election will be held. Units may add provisions to this article if needed.

Treasurer Tips

I entitled this month's article, Treasurer's Tips, but these do not only pertain to treasurers. Anyone who handles money, a debit or credit card or keeps your PTA's records can benefit from these tips

Tip #1 - Keep up-to-date with your financial entries. It may be helpful to keep an envelope with you whenever you will be meeting with other PTA members or your officers. Undoubtedly, they may hand you a deposit to be made, expense reports/bills to be paid, or perhaps a request for account balances. By keeping your requests in one place and only taking them out of the envelope when you complete them, you will may never have to search for another item, again!

Tip #2 - Keep an open mind when asked about account balances, budget items, deposits, etc. You know your books inside and out, but others may not be as familiar. Take any question as an opportunity to bring the person up-to-date.

Tip #3 - Work closely with your president. Your president should be as well-versed on your books as you. Your president and board can only make sound financial decisions with your help.

Tip #4 - Don't be afraid to ask questions of other treasurers or someone you trust. When you encounter a balance issue or budget question that is especially tricky, having another set of eyes look at the question can be all it takes to find the answer!

Tip #5 - Start looking for your replacement as soon



as you take office. Finding a treasurer to replace you when your term ends is your #1 job after balancing your accounts. Perhaps there is someone that has helped you or asked great questions. Don't be afraid to show someone else how you do things. That person just may be the next treasurer

Lastly, remember to have fun! All board positions can be stressful. Laugh at your mistakes; enjoy the successes of your PTA; lean on your fellow board members; and reach out to your membership to get valuable volunteers for those carnivals and fundraisers.



Why it's Important

It's that time again, (in most cases), your PTA officer terms may be up. At your February or March meeting you need to elect your Nominating Committee. The future of your PTA is in the hands of the Nominating Committee. This makes it the most important committee in PTA. It is this committee's job to seek and select the nominees for offices open in your unit, people who will lead your PTA in the coming year. The nominating committee is elected and is comprised of an odd number of people. The president may not appoint the committee and may not be a member of the committee nor attend its meetings. Elected committee members should also be made up of people from different grade levels and should be diverse. Choose someone who is knowledgeable about PTA and aware of the qualifications necessary for each office. The Nominating Committee must be willing to set aside adequate time to do their work with care and without haste.

How does the Nominating Committee Function? First, choose a time and place for a Nominating Committee meeting. This needs to be a priority and should meet as soon as possible and a chairman elected. This meeting should allow time to discuss all selections prior to the election. All discussions of the nominating committee should be confidential. Qualifications of each suggested nominee should be carefully considered as the Committee needs to find the best fit for each position. Remember, the search goes beyond looking around the room and asking who wants to do what. This really is about reaching out to your school community to find just the right person. Being a current officer does not put you on the short list to be eligible for another term nor does it mean you automatically get the nomination. Membership lists should be checked to be sure nominees have paid dues and are eligible to hold office. (If a committee member is nominated, they should excuse themselves while their nomination is being considered.)

The nominating committee then presents their list of candidates at least one month before election. (Check your bylaws as the time frame may be different but ALL names and positions need to be posted 30 days before election). After the presentation, any other interested people may be nominated from the floor. For more info on this or anything regarding Elections and Nominating Committee procedures follow the link:

Confession – last year I attended my first WI PTA Convention. I had been involved in PTA for 5 years at my son's school. Having chaired various committees, I had not thought of PTA being much more than fundraising and a sponsor of family-friendly events for the kids at school. After taking on the role of co-President role in my local unit, I decided to dig a little deeper and find out more about PTA as a whole, and was excited to discover WI PTA hosts an annual convention.

I started to ask around about the convention and was surprised to find our unit hadn't sent a representative in years, nor had our council or other units in our council. The reason – no one knew there was a convention. I don't blame WI PTA. I'm sure they made announcements in one of the many mailers or emails I just never got around to reading.

Since I was willing to attend, my local unit was willing to cover my registration fees as a one-time purchase

under our special projects budget as we didn't have a specific line item for convention or leadership conferences at that time.

Not knowing what to expect, I arrived at the location the day of the event. I showed my membership card (yes, your membership card actually has purpose), collected my Convention materials, and Delegate information and found a place to sit for the First Timers Orientation and Parliamentary Procedure Overview. I remember thinking to myself – wow, this is legit. I'm a voting delegate, part of an organization which is much larger than the unit at my son's elementary school, and I was eager to learn more. After the basics we moved on to the first General Session where WI PTA conducts an open meeting with voting delegates to discuss official matters of the organization such as officer election and passing resolutions. As I met my tablemates and others around me, I discovered many attendees were first timers like me, but many who knew each other from previous years. Turns out this Convention thing has been going on for a while now (2018 marks the 109th year). As we started to talk, it was clear everyone was interested in meeting others and sharing stories about what they were doing in their local PTA unit or council, regionally and at the state or national level.

After the first General Session we moved on to the first rotation of breakout sessions covering topics such as Male Engagement, Meeting with Decision Makers, Every Student Succeeds (ESSA), and Managing Social Media Presence, all led by members from the state and national PTA. Each breakout offered me an opportunity to further network, learn and engage with other members in a fun, interesting manner.

We reconvened as a group for the membership luncheon where I was surprised to find awards presented to units who had met certain membership goals. Goals my unit had met, but didn't qualify for because we hadn't

As the weekend went on, I knew I wanted to learn more. One of the evenings brought an opportunity to visit a variety of exhibitors who were sharing information on things like fundraisers, school carnivals, insurance, STEM/STEAM school assembly programs, and much more in a no-pressure manner. The Reflections luncheon honored the Wisconsin student participants of the Reflection program, and an awards dinner banquet recognized outstanding individuals and supporters of the PTA's mission. Each event offered an opportunity to connect with other members on a local, state and national level.

I'm hoping by now you're thinking to yourself, "We need to send a representative or two to this year's convention". If you are not, you should be. The money my unit spent to send me to the 2017 WI PTA Convention has been returned to us tenfold in terms of accessing information, strengthening membership and opening our eyes to what PTA has to offer our students and families beyond the scope of our local unit. I believe this so much I successfully lobbied my local unit to add a |Leadership/Convention line item to our annual budget, and encourage all units to do the same.

This is a wonderful story to share, and as it is most definitely a children's story.... let us begin:

Once upon a time, two women, without a right to vote and in a time that advocates were not found in every neighborhood, brought forward the idea that mothers and fathers would help them to eliminate threats that endangered children. In the winter of 1897 they set out to light a fire under this great nation!

On February 17, 1897 the crowd of beginner activists surpassed their hopes and brought more than 2,000 people – mothers, fathers, teachers, laborers – even legislators, to the first convocation of the National Congress of Mothers in Washington, D.C. By 1917 37 states, including Wisconsin, boasted a chartered state congress!

It took over fifty years, but finally, in 1970 the National Congress of Parents and Teachers (National PTA) and the National Congress of Colored Parents and Teachers (NCCPT) founded by Selena


Sloan Butler, in Atlanta, Georgia, merged to become a single voice for all children.

PTA is the largest, oldest, volunteer organization dedicated to the advocacy of all children and youth. National PTA is proud to serve as the conscience of the country for children and youth issues. Through refined advocacy skills and by means of family and community education PTA has established programs and helped to bring forward legislation impacting the lives of all children, including:

- Creation of Kindergarten classes
- Child labor laws
- Public health service
- Lunch programs
- Juvenile justice
- Immunizations

Our founders represent women of foresight and courage. We honor

them and the countless others who have gone before us, through the celebration of Founder's Day every **February 17th**. Alice McLellan Birney, Phoebe Apperson Hearst and Selena Sloan butler provided a legacy of which we can be proud. They saw and taught the power of action and moved beyond the accepted



barriers of their time to make a change for all children. Founder's Day is a time to look back and move forward by taking pride in our achievements and enhancing our commitment to move forward.

Evers: Our plan focuses on local strategies to close gaps

Statement on approval of Wisconsin's ESSA Plan

MADISON —State Superintendent Tony Evers issued a statement today on the approval from the U.S. Department of Education of Wisconsin's Consolidated State Plan to implement the Every Student Succeeds Act (ESSA), federal law governing PK-12 education.

"Wisconsin's ESSA plan is an opportunity to focus on local strategies to close opportunity and achievement gaps for all kids. We're excited to pursue the hard work that will entail and look forward to building on the important relationships we have forged through our Equity Council.

"Wisconsin's ESSA plan

- Focuses on the ambitious goal of cutting the achievement gap in half in six years for all subgroups of students in English language arts, mathematics, and graduation rates.
- Has a clear structure for rating all schools using a one-hundred-point system that is straightforward and will effectively identify schools for additional supports and interventions.
- Uses new research focused on implementation science to support locally determined interventions for school improvement in the lowest-performing schools and is coordinating that work with Individuals with Disabilities Education Act (IDEA) requirements to lead to better outcomes for all students and streamline requirements for local educational agencies."
